## Storms Kill At Least 4 In Houston Leaves Thousands Without Power.

### Storms Can Disrupt Technology



The wind estimated to be in excess of 70 mph toppled trees

A severe storm in Houston, the fourth-largest city in the US, has killed at least four people and left over 800,000 homes and businesses without power.

At least four people were killed due to the storm, Houston Mayor John Whitmire told reporters in a news briefing on Thursday night, "We have a storm with 100 mph winds, the equivalent of Hurricane Ike, considerable damage downtown." Whitmire said that the region may have been hit by tornadoes as well and urged people to "stay at home". "There's trees across roadways across

Houston," he said, adding, "I ask everyone to be patient, look out for your neighbours. It will take 24 hours for a lot of this power to be restored, some will require 48 hours." Houston Fire Chief Samuel Pena told reporters that of the four fatalities, at least two were caused by fallen trees, while another due to a "crane that was blown over by the wind". Houston metro. Officials urged residents to keep off roads following Thursday's storms, as many were impassable and traffic lights were out. The storm system moved through swiftly, but flood watches and warnings remained Friday for Houston and areas to the east. "Houston Mayor John Whitmire said four people died during the severe weather. At least two of the deaths were caused by falling trees and another happened when a crane blew over in strong winds, officials said." AP report.

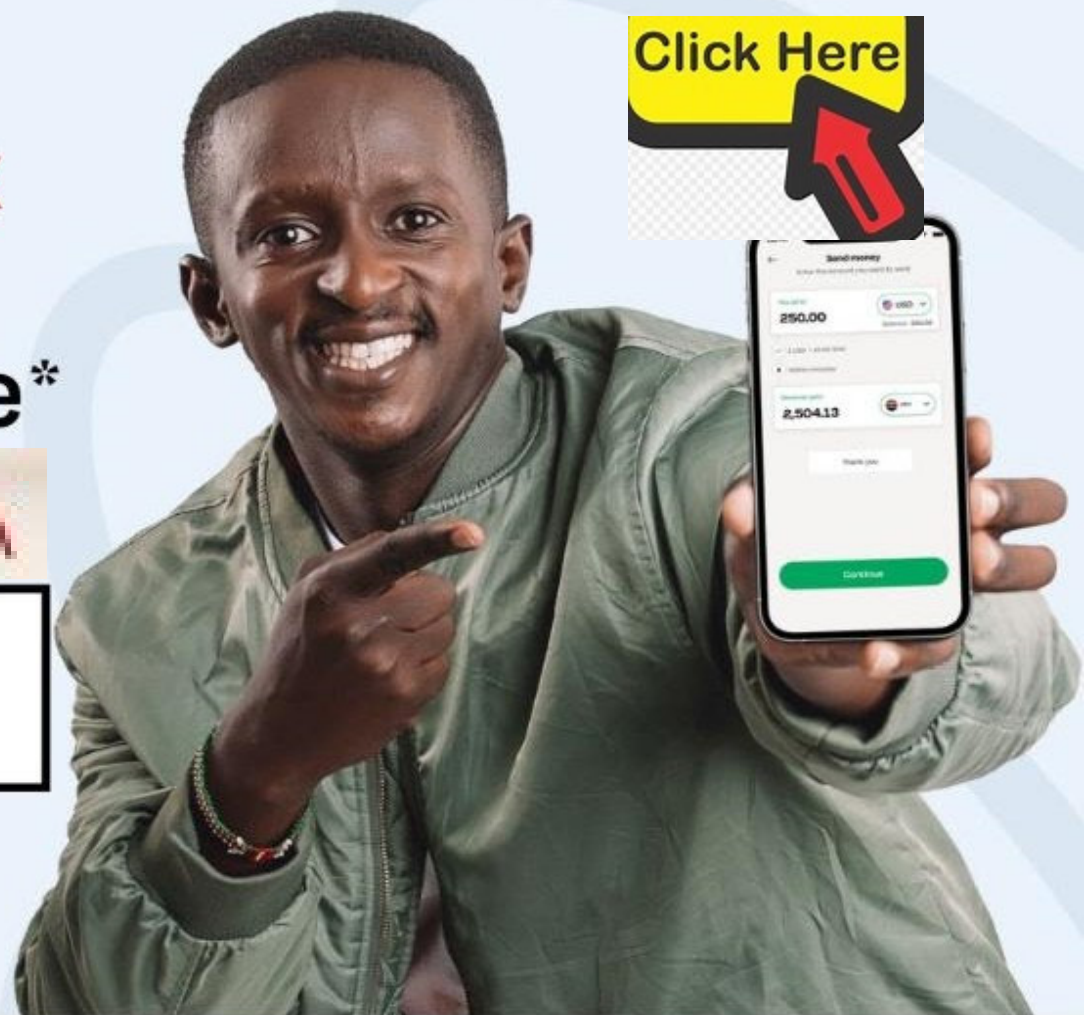
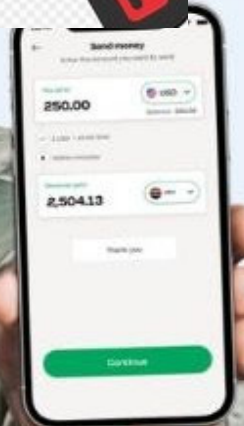

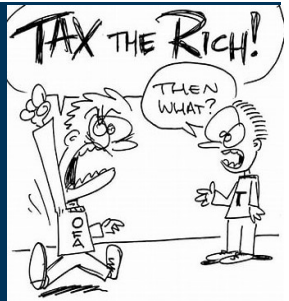

# Increasing Taxes In Kenya Will Make The Poor To Suffer More.



**Y**ou wake up in the morning, and the pain could be caused by natural disasters or through the government that people elected! Finance Bill 2024 has gone through the first reading, and we are aware that President Ruto is out to introduce a new tax that is becoming a surprise to many Kenyans. After we have been battered by floods, the government has come up with a new tax model. The motor vehicle tax @ 2.5% of the vehicle's value generating a minimum of Ksh 5k to a maximum Ksh 100k per vehicle per annum! Globally, an asset is not taxed.

Recently, Hon Ruku, a member of Parliament from Mbeere constituency was in difficulties in to elaborate in national television on the relevance of the motor vehicle tax or why it is good for Kenyans taking into consideration that income tax is charged on an income per year yet motor vehicle may not be an income and could even be a liability! ## Finance Bill 2024



2024 was met with nine thousand interventions, specifically on affordable housing deductions, but the government forced the item into the provisions of the law! Budget is the estimate of the revenue against expenditure. Public participation should be qualitative and quantitative before settling to final policy papers. We donate power to the body politic and fund it through taxation. We do our appropriations but the revenue targets are never achieved, leading to more debt to finance the deficit. Our problem as a country however is not pegged on revenue collections but on expenditure! We have so much debt. President Ruto has borrowed over Ksh 4.5 trillion in partly two years of his presidency compared to his predecessor whom he vindicated on economy issues. He borrowed Ksh10.5 trillion in ten years but with major infrastructures to support his stand on the debt with the SGR as his golden trophy! Kenyans can relate well with the debt of the fourth regime as having added value to our economy! Since the debt is sovereign, we should demand to have an audit of our current debt standings! We are a sovereign in debt. The world bank want to see more contribution from the sovereign. We seem to have fake debt and are now strangling the sovereign to pay it. the name Ojijo from western Kenya came up with Kavirondo Tax Association to protest against white settlers. Ojijo felt that his community at the lake basin was being unfairly over taxed after the white settlers send men from the community to the world war as a taxation model, then again came for the community's cows which was a form of taxation then, leading to a protest. We expect the government to be responsive to the pains that people may be in.

# GERISHON KIRIMA

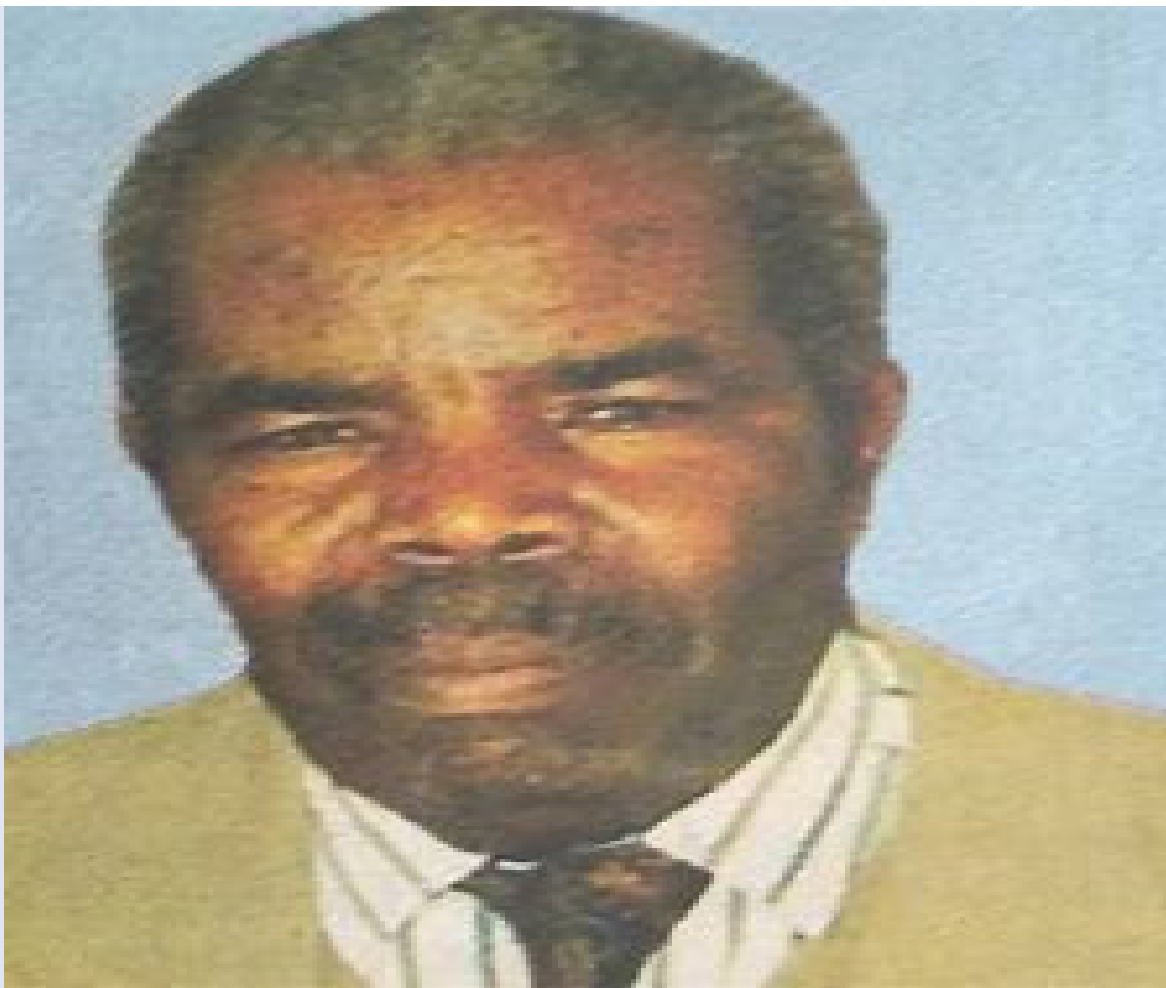
**He was the pioneer carpenter at the University of Nairobi and operated a small workshop in Bahati and later on in Kaloleni.**

**K**irima relocated from his village to the Kinangop Plateau where he started a carpentry business. In the early 1960s after Kenya had attained independence, he moved to Nairobi and registered his business Kirima and Sons Ltd.

He was the pioneer carpenter at the University of Nairobi and operated a small workshop in Bahati and later on in Kaloleni. His first wife, Agnes, would help attend to customers at the Kaloleni workshop.

Taking advantage of the rural-urban migration to Nairobi that resulted from the dawn of independence and the end of the state of emergency, Kirima opened bars and butcheries in Asian and African neighborhoods to cater for the growing moneyed class. He is considered a pioneer of nyama choma, a popular Kenyan delicacy.

By 1967, and to the surprise of the better educated African civil servants, Kirima had saved enough money to buy 500 acres of land in Nairobi from an Italian Donenico Masi, which the De Masi family have contested claiming that Kirima grabbed the land since he does not have



the title deed.

In the same year, Kirima bought two more farms in Nairobi - 108 acres from Charles Case and 472 acres from Percy Randall. With these acquisitions, Kirima had positioned himself to be a major meat supplier for Nairobi.

As chairman of the African Butchers Association (later the Kenya National Butchers Union), he successfully lobbied the government for permission to sell meat in the city, a privilege that was hitherto reserved for the still settler-controlled Kenya Meat Commission (KMC) which

did not buy meat from African farmers.

Kirima started a private abattoir in Njiru, a development that some believe led to the eventual collapse of the KMC years later.

He would venture into the transport business by launching the Kirima Bus Services.

However, the business didn't last long following the liberalization of upcountry transportation by the government in 1973. He opted to focus on real estate mostly concentrating on building rental housing in the low income Eastlands area of Nairobi.

Kirima served for many years as a city councilor and briefly as deputy mayor.[4] In 1989, Starehe Constituency Member of Parliament Kiruhi Kimondo was dismissed by his party KANU in 1989. By-elections were held the same year. Kirima contested the seat on a KANU ticket and won. He remained in office until the 1992 General Elections when he lost the seat to his predecessor Kimondo.

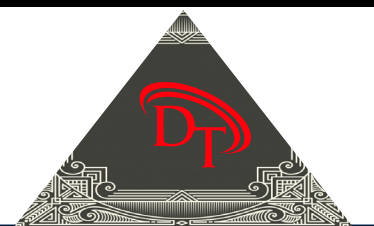

After succession wars, Daily Nation reported that in 2020, family members finally agreed on how to share his property after a deal brokered by the High Court.

The ex-lawmaker owned several parcels of land in Nairobi county. Among them were pieces in Kariobangi and Njiru, which were sub-divided and shared equally among family members.

Kirima also owned over 20 acres of land in Kisaju, Kajiado county. The property was distributed to all beneficiaries.

It also agreed that the land occupied by squatters would be shared equally once the court resolved the case.

# US unveils proposal to ease restrictions on marijuana.

In a new legal opinion made public on Thursday, the Justice Department's Office of Legal Counsel criticized the DEA's long-held approach for how it determines whether a drug has an acceptable medical use,

**T**he U.S. Justice Department on Thursday unveiled a historic proposal to ease restrictions on marijuana, a rule that if enacted would also enable more research on its medicinal benefits.

The proposal, first announced in April, would reclassify cannabis from a so-called schedule one drug to a schedule three. Schedule one drugs, such as heroin, are considered highly addictive with no medical benefits, while schedule three drugs are considered to have a moderate to low potential for physical and psycho-



logical dependence.

The U.S. Food and Drug Administration said it found "some credible scientific support for the use of marijuana in the treatment of chronic pain, anorexia related to a medical condition, and nausea and vomiting."

"Additionally, no safety concerns were identified in the FDA's review that would indicate that medical use of marijuana poses unacceptably high safety risks," the proposal says.

President Joe Biden, a Democrat who is running for reelection in November, initiated a review of the drug's classification in 2022, fulfilling a campaign promise that was important to left-leaning members of his political base.

Currently, the drug falls under the Drug Enforcement Administration's (DEA) class that includes heroin and LSD. It would be moved to a group that contains ketamine and Tylenol with codeine.

Reclassifying marijuana represents a first step toward narrowing the chasm between state and federal cannabis laws. The drug is legal in some form in nearly 40 states.

While rescheduling the drug does not make it legal, it would open up the doors to more research and medical use, help lead to potentially lighter criminal penalties and increase investment in the cannabis sector.

In a new legal opinion made public on Thursday, the Justice Department's Office of

Legal Counsel criticized the DEA's long-held approach for how it determines whether a drug has an acceptable medical use, calling it "impermissibly narrow."

The opinion also found that the DEA should "accord significant deference" to the U.S. Department of Health and Human Services' (HHS) scientific and medical determinations.

According to the proposal, HHS's assistant secretary for health recommended that the DEA should place marijuana into schedule three back in August 2023.

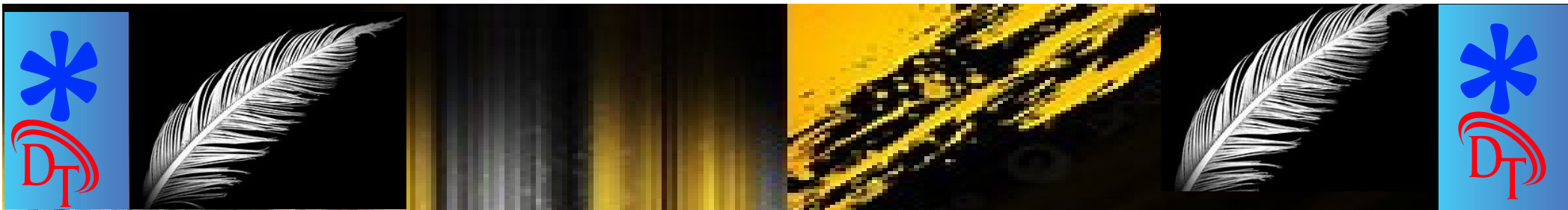
The DEA, however, has yet to make its own determination. If marijuana's classification were to ease at the federal level, cannabis companies could

reap significant benefits, such as being eligible for listing on major stock exchanges and more generous tax deductions.

Moreover, they could face fewer restrictions from banks. With marijuana illegal federally, most U.S. banks do not lend to or serve cannabis companies, prompting many to rely on cash transactions.

The public will get 60 days to submit comments on the Justice Department's proposal. Shared article for awareness

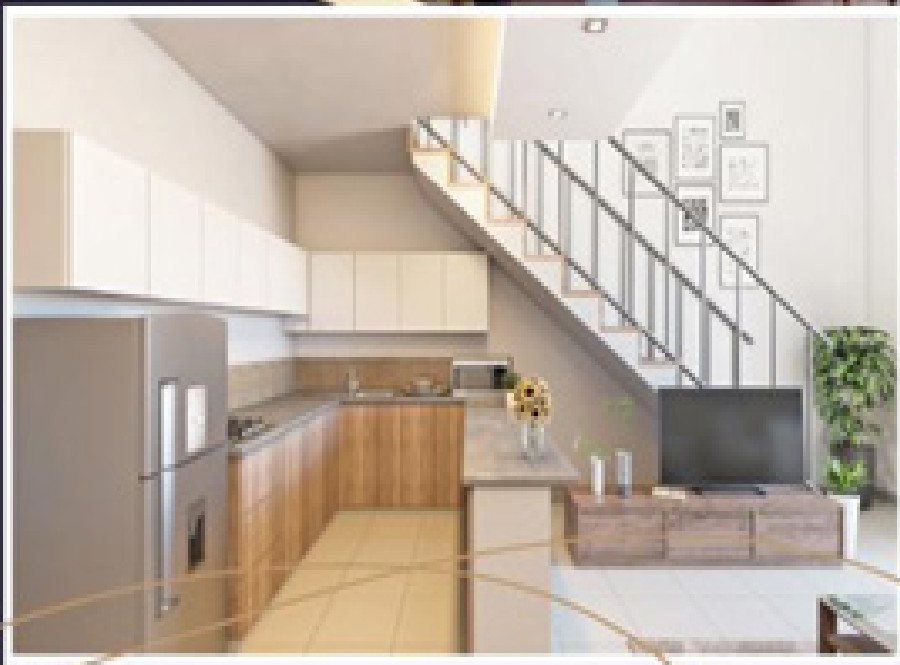

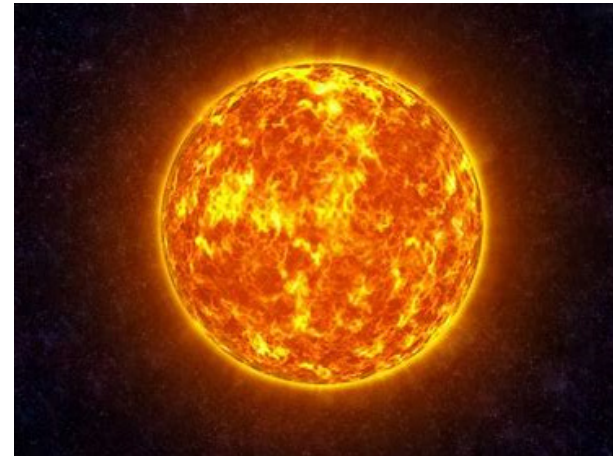
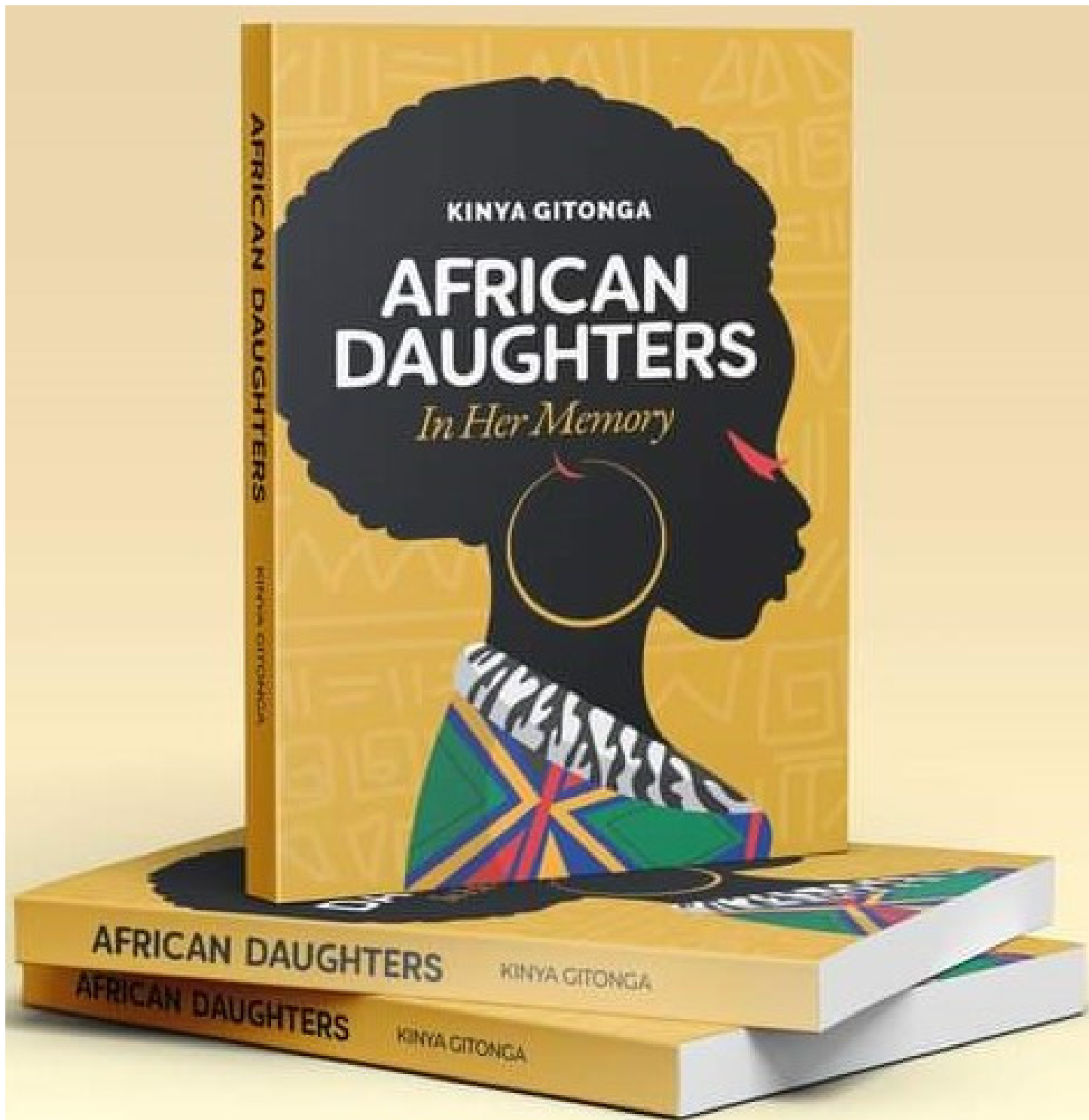

### BIDEN HIGHLIGHTS



The split in the Democrats' approach to the war has become stark in recent weeks, leading to tension among liberal lawmakers.

Pro-Israel House Democrats have expressed solidarity with the embattled nation while Biden and progressive lawmakers have shown skepticism, if not outrage, over Prime Minister Benjamin Netanyahu's plans to invade Rafah.

In a rebuke to the White House, House Democrats teamed up with Republicans to pass the bill to force Biden's hand, highlighting the precarious position some left-leaning lawmakers find themselves in over their support for Israel.

The defense wants to undermine Cohen's credibility as a witness testifying against Trump, and highlighted the many instances of when he lied in years past, even under oath. Trump's attorney focused on Cohen's 2017 House Intelligence Committee testimony when he lied under oath during special counsel Robert Mueller's investigation into Trump's links to Russia.

The defense also tried to show that Cohen can't be trusted. In Blanche's line of questioning, he depicted Cohen as a serial liar, citing instances when he lied under oath, essentially arguing that if Cohen lied then, the jury has no reason to believe his testimony under oath now.

Perhaps one of the biggest moments of the day was when Blanche attempted to sow doubt about Cohen's testimony regarding an October

2016 call Cohen made to Trump's former bodyguard Keith Schiller, to talk to Trump about the hush money payment. Message and call logs indicate that the short call was actually Cohen asking Schiller how to deal with a prank caller.

Remember: The prosecution has to prove beyond a reasonable doubt that Trump not only knew about the hush money payments made to adult film actress Stormy Daniels, who alleges she had sex with Trump in 2006, but that he also directed them.

Trump is facing 34 felony counts of falsifying business records as part of a larger scheme to disguise the payments to protect his presidential campaign ahead of the election. Trump has pleaded not guilty to the charges and denies having a sexual encounter with Daniels.



Trump's defense attorney referred back to Cohen's testimony on Monday regarding a call he had with Keith Schiller, Trump's then-bodyguard, on Oct. 24, 2016. Cohen previously testified that he called Schiller that evening so he could talk to Trump about moving forward with the Daniels hush money payment.

Blanche said in court that according to text message logs that evening, Cohen actually was contacting Schiller to ask about how he could deal with a 14-year-old prank caller. Schiller then asked to call him. According to the call logs, the conversation lasted less than two minutes.

# “One Chip Challenge” Led To Massachusetts Teen’s Death, Autopsy Finds

**M**assachusetts teenager who participated in the “One Chip Challenge” died from cardiac arrest hours after eating the spicy tortilla chip, an autopsy concluded. The Office of the Chief Medical Examiner determined that Harris Wolobah of Worcester had ingested a high amount of a chili pepper extract. The 14-year-old died on Sept. 1, 2023. Chip maker Paqui pulled the product from store shelves days after his death. Harris Wolobah’s cause of death was listed as cardiopulmonary arrest “in the setting of recent ingestion of food sub-

stance with high capsaicin concentration.” Wolobah also had an enlarged heart and a congenital heart defect, the medical examiner found. The teen’s mother, Lois Wolobah, told WBZ-TV last year that she got a call from the school nurse at Doherty High School, saying Harris fainted after eating the chip a friend gave him. He later passed out again at home and was taken to an emergency room where he died. The family at the time said Wolobah was a healthy basketball player with no known allergies.

“I hope, I pray to God that no parents will go through what I’m going through. I don’t want to see anybody hurting the way I’m hurting,” Lois Wolobah said. “I miss my son so much. I miss him so much.” What is the “One Chip Challenge”? The “One Chip Challenge,” which gained popularity on social media, contains a single chip inside a box labeled “Carolina Reaper” and “Naga Viper Pepper.” On the back of the package a warning label says “Keep out of reach of children.” WBZ-TV found the chips in a store about 10 minutes from Wolobah’s school last fall. While the Paqui One Chip

Is capsaicin dangerous? Capsaicin is what makes chili peppers spicy and the level of capsaicin in a given product is measured in Scoville heat units.

The tortilla chips in the “One Chip Challenge” are made with two of the hottest, with the Scoville heat unit ranging between 1.4 million and 2.2 million. Jalapeno peppers, by comparison, are only 2,500 to 8,000 Scoville. Capsaicin can obviously irritate the mouth and throat but can also cause nausea, vomiting, and stomach pain. But in very large doses, it can cause more serious problems such as allergic reactions, damage to the esophagus, rapid heart rate, chest pain, trouble breathing, and even heart attacks, the National Capital Poison Center says.

Marshall says that while the product is no longer in stores, parents should warn their kids to stay away from similar social media challenges and resist peer pressure to eat dangerously spicy foods. If you or your child develop trouble breathing or chest pain after eating capsaicin, call 911.

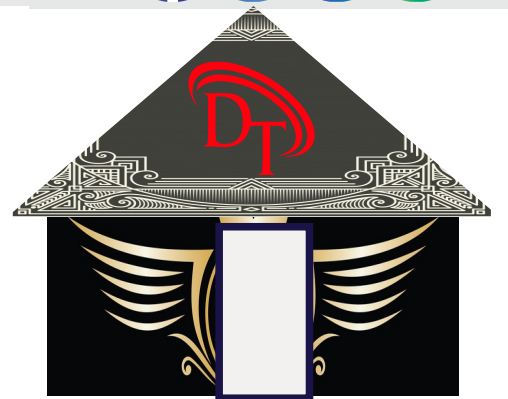

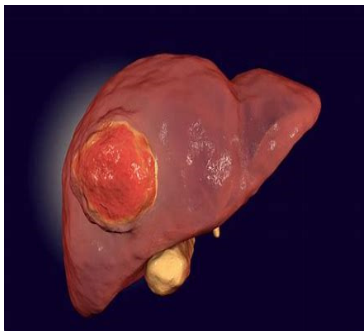

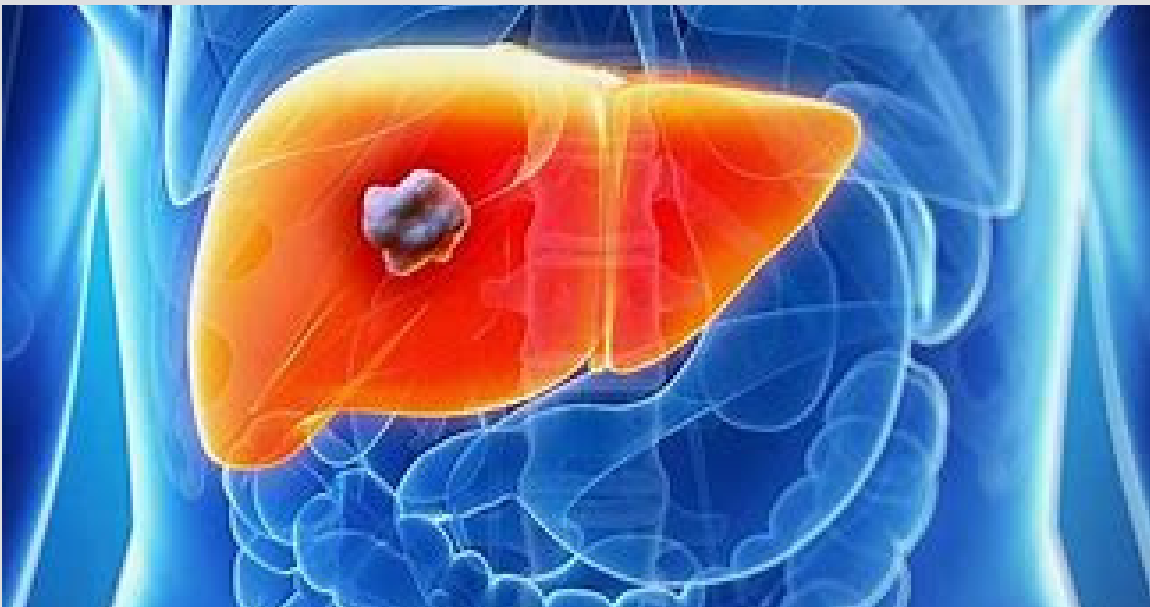

Most people don't have signs and symptoms in the early stages of primary liver cancer. When signs and symptoms do appear, they may include:

Yellow discoloration of your skin and the whites of your eyes (jaundice)

Liver cancer happens when liver cells develop changes (mutations) in their DNA. A cell's DNA is the material that provides instructions for every chemical process in your body. DNA mutations cause changes in these instructions. One result is that cells may begin to grow out of control and eventually form a tumor — a mass of cancerous cells.

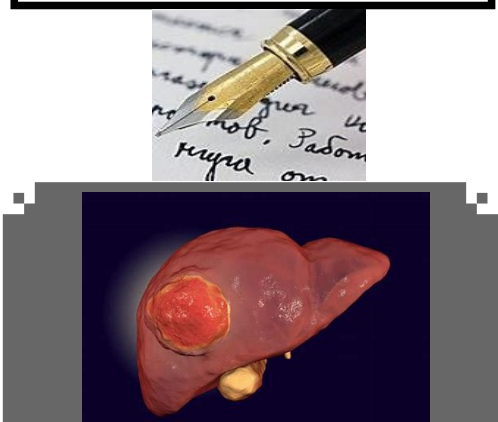
Sometimes the cause of liver cancer is known, such as

with chronic hepatitis infections. But sometimes liver cancer happens in people with no underlying diseases and it's not clear what causes it.

Factors that increase the risk of primary liver cancer include:

Chronic infection with HBV or HCV. Chronic infection with the hepatitis B virus (HBV) or hepatitis C virus (HCV) increases your risk of liver cancer.

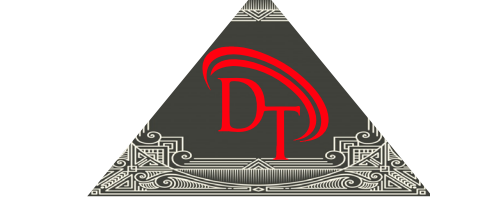

Cirrhosis is scarring of the liver, and it increases the risk of liver cancer. You can reduce your risk of cirrhosis if you:

Drink alcohol in moderation, if at all. If you choose to drink alcohol, limit the amount you drink. For women, this means no more than one drink a day. For men, this means no more than two drinks a day. Maintain a healthy weight. If your current weight is healthy, work to maintain it by choosing a healthy diet and exercising most days of the week.

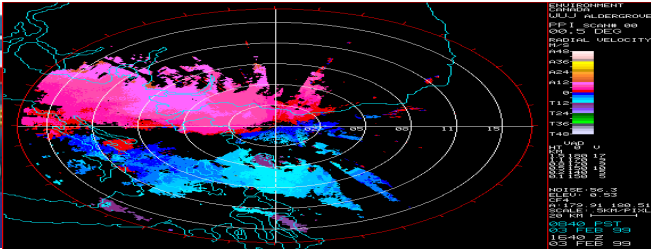

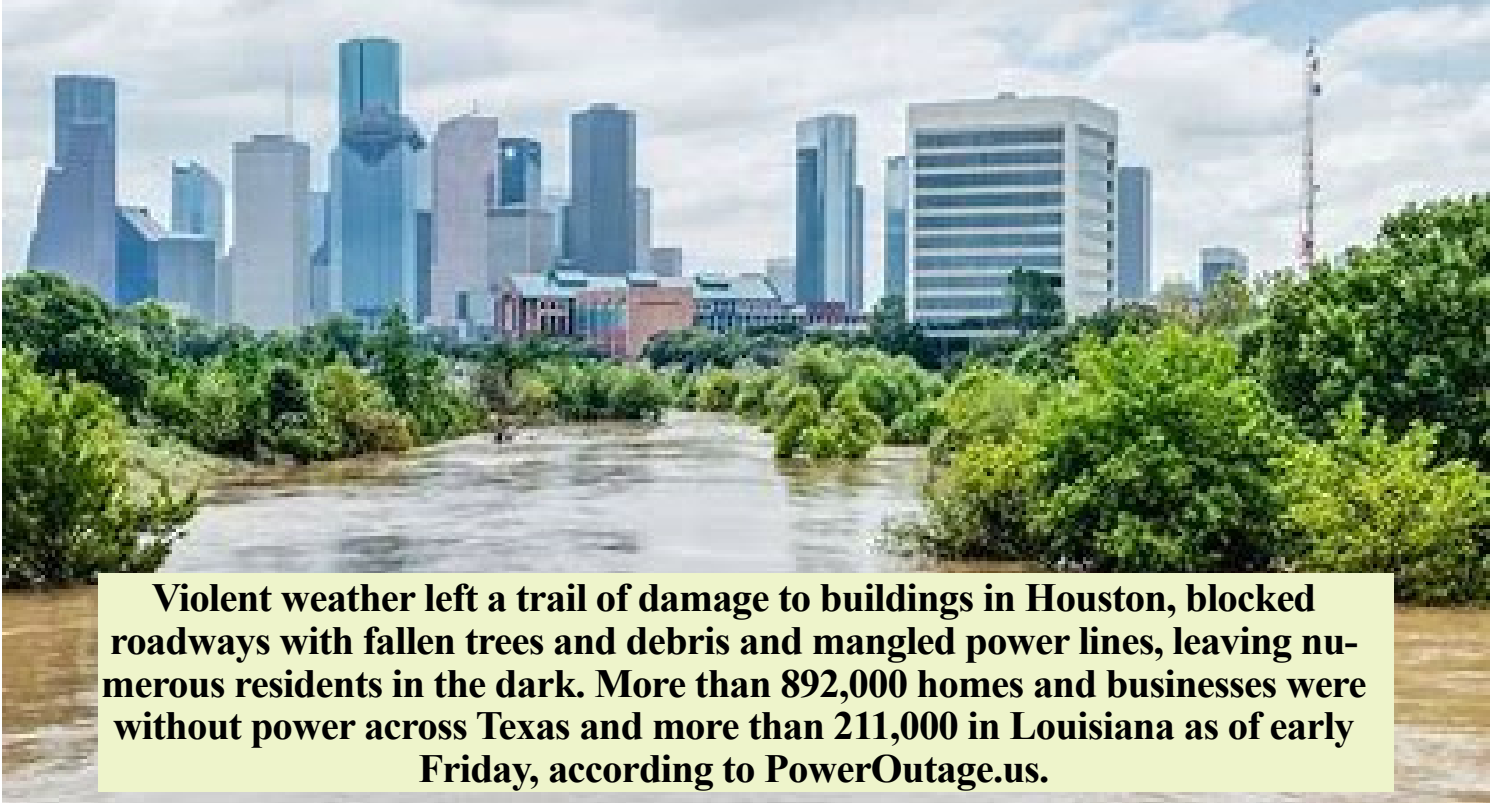

**S**torms battered Texas and Louisiana late Thursday and early Friday with destructive winds and torrential rain, leaving at least four dead, flooded roads and more than 1 million homes and businesses without power —

**Violent storm conditions in Houston have blown out skyscraper windows, partially collapsed a nightclub and partially ripped roofing off the downtown Hyatt Regency, showering the hotel lobby with rain and debris, according to witness video. CenterPoint Energy says its skyscraper in downtown Houston has sustained damage of the storm, according to a spokesperson.**

and more floods could plague parts of the Gulf Coast Friday. At least four people died as the severe weather blasted through Houston, the mayor's chief of communications Mary Benton told CNN. Fallen trees appear to have caused two of the deaths, and a crane accident caused another, Houston Fire Department Chief Samuel Peña said in a press conference Thursday night. Violent weather left a trail of damage to buildings in Houston, blocked roadways with fallen trees and debris and mangled power lines, leaving numerous residents in the dark. More than 892,000 homes and businesses were without power across Texas and more than 211,000 in Louisiana as of early Friday, according to PowerOutage.us. The storm was so powerful that it blew out the windows of buildings in downtown Houston, littering the area

with glass as traffic lights went dark. Shoppers at a Costco in Houston used their phones as the only source of light as they huddled in the dark inside the store when the power went out, with employees closing the doors to block out the rain and winds. Soaking storms will shift east on Friday and target more of the Gulf Coast after rumbling to life Thursday afternoon in parts of Texas. The large cluster of thunderstorms brought with it a flash flood threat from the heavy downpours and severe storm dangers in the strongest cells. More than 30 million people are at risk of severe weather Friday across parts of the Gulf Coast, with 1 million people under a Level 3 of 4 moderate risk of excessive rainfall. Significant swaths of Mississippi and Alabama are under the moderate risk of excessive rainfall on Friday. A larger area from the Texas-Louisiana

state line to Georgia and the Florida Panhandle is under a Level 2 of 4 risk. Drenching storms will likely last into Friday morning for parts of the Gulf Coast. An initial round of flash flooding is likely in the first half of Friday before rain starts to taper off in the afternoon. Another bout of heavy rain will develop Friday night and continue into the earliest hours of Saturday morning, working over the same areas hit earlier in the day. These storms could produce rainfall rates of 2 to 3 inches per hour, and quickly restart or worsen any ongoing flooding.

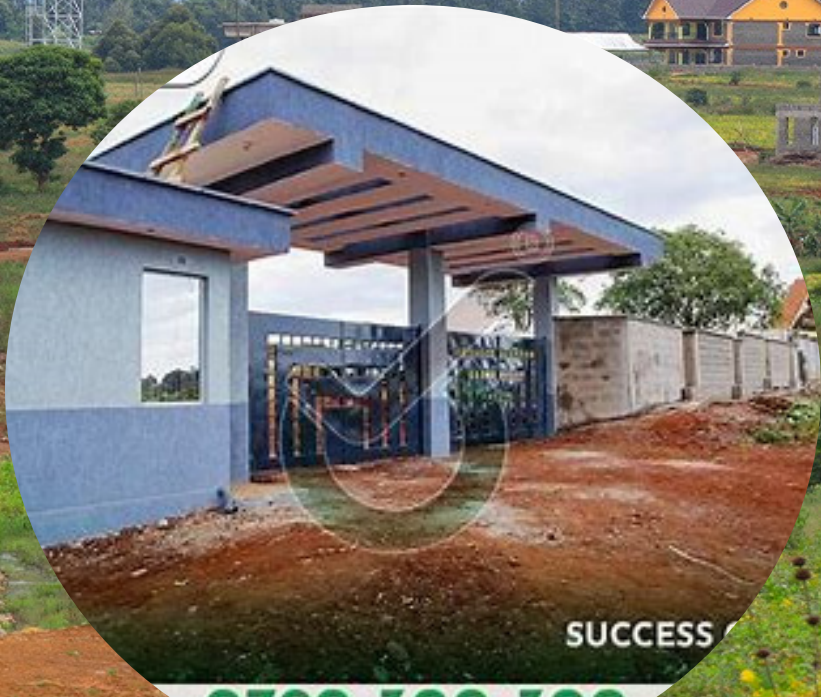

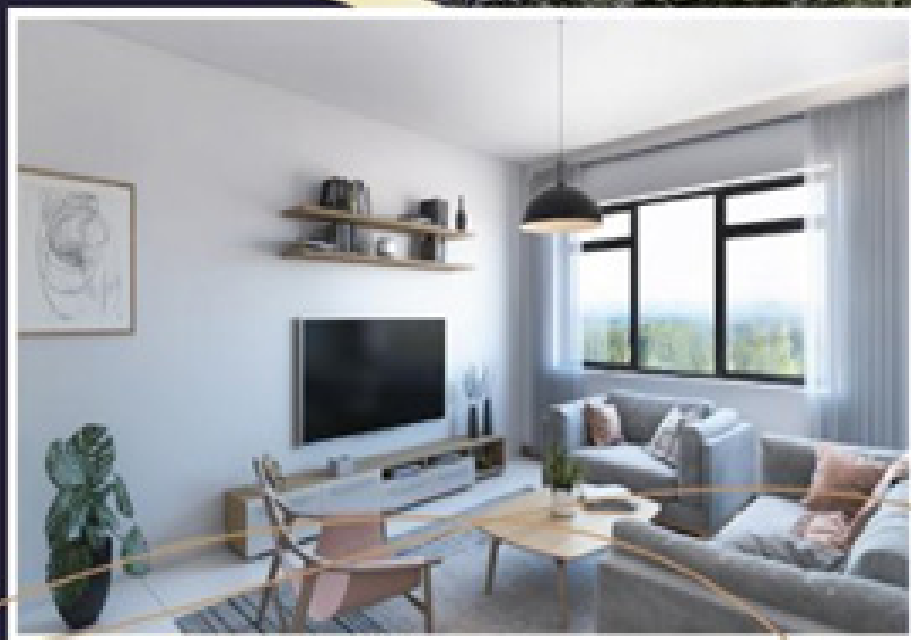

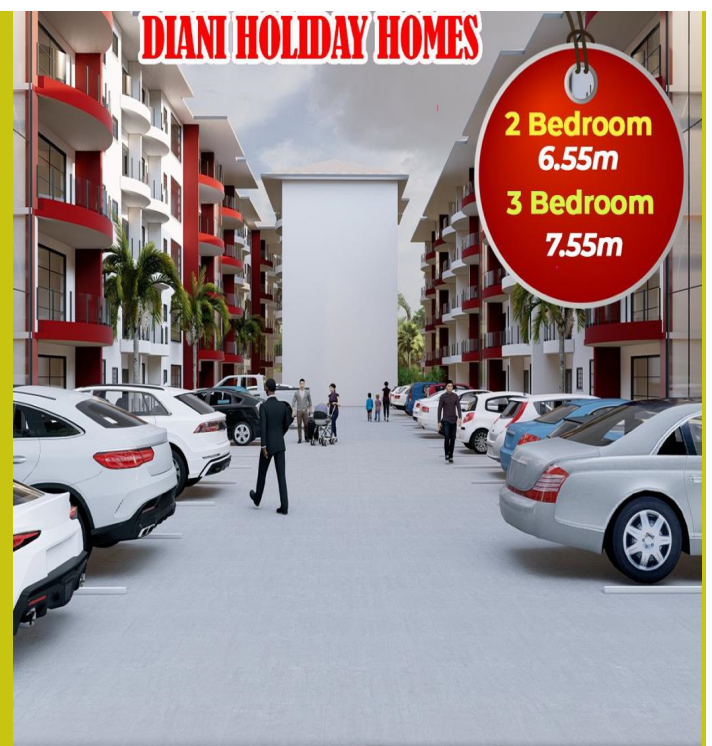
